

TERMS AND CONDITIONS OF GOD BUDDIES MEMBERSHIP

- I. Please read carefully and if you do not return the membership form or cancel the membership within fourteen (14) days of the date of the letter, we will deem that you are agreeable to all terms hereof and we are agreeable to be a GOD Buddy member.

II. Membership duration

This is a yearly membership and shall expire at the end of period as stated on the membership card. The membership will be renewed automatically and payment for the renewal will be deducted from your redeemable points or if you make payment by cash. At any time during the membership term, you can choose to terminate the membership but no refund of the membership paid will be given.

III. Redeemable points

A member will earn redeemable points for non-discounted dive trips, when a friend is introduced and accepted as a member, or when he/she joins a non-discounted trip or when he/she undertakes a dive course with GOD. These redeemable points can be used for current and future dive trips as part payment for the said trip.

- IV. The redeemable points earned shall be as follows:

5 % of trip cost if trip is booked with deposits paid 4 months in advanced
3 % of trip cost if trip is booked with deposits paid 1-4 months in advanced

The same percentage above applies if you introduced a friend or friends as divers or non divers for any dive trip.

2.5 % of course fee for any diving course.

30 points for introduction of a new member for GOD Buddies

The redeemable can be transferred to any other member subject to a deduction of an administrative fee of 50 points. The redeemable points will expire once the membership is terminated or expires.

V. Due care and behavior

A member should at all times maintain a good diving etiquette and show care for the Ocean and do not engage in activities that may damage the fragile ecosystem of the Ocean. A member should practice safe diving and dive within their physical and qualified limits. If any member discredits GOD, its servants or GOD Buddy members without justifications or cause harm to others, then the membership will be revoked and no monies returned.

- VI. Any individual who wishes to become a Member must agree to be bound by these Terms and Conditions, as varied from time to time.
- VII. GOD may refuse an application for Membership and reserves the right not to disclose the reasons for such refusal.
- VIII. GOD may terminate a Membership without notice and for any reason, including if the Member fails to comply with these Terms and Conditions. Termination of Membership will result in forfeiture of remaining Points in a Member's Account.
- IX. Points will be recorded in a Member's Account. Upon registration the Member will be given a Membership Number.

- X. The Member with sufficient Points is eligible to redeem, and he/she may do so by fulfilling the relevant form provided by GOD. Once the Points are redeemed and accepted by GOD cannot be revoked, cancelled, returned or exchanged, and the affected Points will not be reinstated. GOD reserves the right to decline the redemption of the Points by the Members by any reason whatsoever.
- XI. The Membership of GOD is not transferable and belongs exclusively by GOD. Points, and any rights they confer, cannot be sold, transferred, assigned or otherwise dealt with except in accordance with these Terms and Conditions. Points have no cash or monetary value. GOD may, at its absolute discretion, allow the transfer of Points under certain exceptional circumstances GOD may change, at any time and without prior notice.
- XII. GOD reserves the right to suspend or terminate the Membership and the Points programme at any time without prior notice.
- XIII. As a member of GOD you may join any diving trips organized by GOD at a special price or undertake any diving course or any diving certification by PADI, SDI or IATD at any level. Nevertheless, because GOD is only acting as your organiser of the diving trip or the diving course GOD shall not be held liable to you in the event that you suffer injury, loss or damage of any kind whether caused negligently or otherwise in the course of or arising out of the provisions, of those services. This is notwithstanding the governing law with regards to the relationship between the instructor and student with regards to the diving course.
- XIV. If the Member is joining the diving trip organized by GOD, in an unlikely event that we will change or cancel your booking once it is confirmed, we shall do our best endeavor to inform you as soon as we reasonably can. GOD reserves the right to make changes that are not significant and to correct errors in your diving trip at any time without being liable to you.
- XV. The Member shall assume the danger, risk and nature of using SCUBA diving equipment and diving activity and GOD shall not be held liable in any circumstances for any suffering, injury, loss or damage of any kind whether caused negligently or otherwise in the course of or arising out of using of any SCUBA equipment and any activity organized either directly or otherwise by GOD.
